Sub: Complaint against Shri Alok Verma, an IFS Officer and former Secretary, NCERT - reg.

The undersigned is directed to say that CVC vide OM dated 05.06.2012 has forwarded a complaint regarding irregularities in purchase of maplitho paper, cover paper, supply of manpower contract etc. at NCERT in 2011-12. The complaint was investigated and some charges leveled in the complaint were substantiated and a report was made to the Central Vigilance Commission. The Commission vide OM dated 22.06.2018 advised to identify the officials responsible and approach the Commission for 1st stage advice. In pursuance of the Commission's advice, NCERT has identified the role of Shri Alok Verma, (IFS Officer) former Secretary, NCERT responsible for the irregularities and allegations have been framed against him. A statement indicating allegations against Shri Alok Verma along with relevant documents is forwarded herewith.

2. In view of the above, it is requested that version of Shri Alok Verma on the allegations may be obtained and furnished the same along with Bio-data of Shri Alok Verma to enable us to submit a proposal for first stage advice of the Central Vigilance Commission.
